B) PRE-QUALIFICATION CRITERIA (PQC):

Only manufacturer or authorized distributor or authorized dealer of make- AIRAUTO INDUSTRIES need to submit the offer, as inquired items are pumps and their spares of Airauto make pumps. In case of authorized distributor or authorized dealer bidder have to submit valid authorized distributor /dealership certificate along with their offer, otherwise their offers will not be considered.

C) Special terms & Conditions:-

1. FITMENT GUARANTEE:

Being OEM supply, the supplied spare should be one to one replacement, there should not be any fitment problem.

- 1.2 The EMD should normally remain valid for a period of 45 (Forty Five) days beyond the final bid validity period.
- 1.3 A bidder's EMD will be forfeited if the bidder withdraws or amends its tender or impairs or derogates from the tender in any respect within the period of validity of the tender or if the successful bidder fails to furnish the required Performance Security within the specified period or execute the order in full.
- 1.4 EMD of the unsuccessful bidders should be returned to them at the earliest after expiry of the final bid validity period and latest by the 15th day after award of the contract. EMD should be refunded to the successful bidders on receipt of Performance Security or execution of PO.
