### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

### 2. Scope of Supply

Scope of supply (Bid price to include all cost components) : Only supply of Goods

### 3. Buyer Added Bid Specific ATC

#### **VENDOR EVALUATION CRITERIA:**

1) Only offers from manufacturers will be considered for evaluation. Offers from dealers& traders will not be considered.

2) Minimum 1 PO successfully executed for fabrication and supply of SS317/316 item to any Central / State Govt Organization / PSU / Public Listed Company within last 7 years ending on tender floated date with documentary proofs (PO copies & successful performance certificate from end user) shall be produced.

3) Time Schedule: Total time period for executing this order is 2 months from the placement of order.

#### **ITEM ACCEPTANCE CRITERIA:**

1. The supplied items shall be of as per tender specification.

2. Seamless pipe should be used for fabrication.

3. Proper care should be taken during welding as these items will be used at high temperature.

4. All the weld joints are to be DP tested and no indications are allowed in DP test 5. Items shall be along with material test certificate from NFC/NABL accredited lab for the material used without fail.

#### **IMPORTANT NOTES FOR BIDDERS**

1. Offers mentioning any terms which are contradictory to our NIT shall be summarily rejected.

2) Bidder shall furnish Land boarder certificate enclosed herewith without fail, without which your offer shall not be considered for evaluation.

#### **3) DELIVERY INSTRUCTIONS:**

a) Stores are to be delivered to the Store Keeper (Receipt and Inspection) at the place of delivery

stipulated in the Contract between 10.30 a.m. and 3.00 p.m. on working days.

b) No stores shall be accepted by the Store keeper (Receipt and Inspection) unless delivery challan giving full details of the Contract Number and Date and Description of Stores, Quantity, Make, Unit, Gross Weight Tare Weight are submitted with the stores. In the absence of any of the above, the Store Keeper (Receipt and Inspection) shall refuse to take delivery of the stores. The supplier should submit the warranty/ guarantee card/certificate along with the Delivery Challan in whichever case it is applicable while effecting delivery of item.

c) A receipt for the packages only and not for the contents will be given by our Central Stores initially. The Suppliers are advised to properly seal the package. Final receipt will be given from the Central Stores, after inspection.

Driver's Note: The drivers, while bringing the material in motor vehicles into NFC premises, shall carry their respective original driving license to facilitate security checks properly before entering inside NFC premises without any delay.

In case the contractor is unable to deliver the goods within the delivery schedule stipulated in this Contract, it is mandatory on his part to approach the purchaser for extension of the delivery date with justification for the delay for consideration of the purchaser.

The contractor should deliver the goods only after getting the delivery period extended by the purchaser. In case the contractor fails to adhere to this condition and deliver the goods to the consignee after expiry of the delivery date without getting the delivery period extended, it is not only that the consignee will not receive the goods dispatched by the suppliers but the bills if any furnished by the contractor will be rejected without any liability and obligation on the part of the Purchaser.

This will not in any way prejudice the other rights of the purchaser under the terms and conditions of the Contract.
