If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.

2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. 3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

4. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. 5. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY. **6. Inspection of Stores by Nominated Inspection Authority / Agency of buyer or their authorized representatives**

An independent third party Professional Inspection Body can help buyer in mitigating buyer's risk with pre-

dispatch/post-dispatch inspection in order to ensure that equipment, components, solutions and documentation conform to contractual requirements. The buyer has a right to inspect goods in reasonable manner and within reasonable time at any reasonable place as indicated in contract. Inspection Fee/ Charges (as pre-greed between buyer and Inspection Agency) would be borne by the buyer as per their internal arrangement but may be recovered from the seller if the consignment failed to conform to contractual specification and got rejected by the Inspection Officer. If so requested and accepted by the seller, initially seller may pay for inspection charges as applicable and get the same reimbursed from buyer if consignment accepted by the Inspecting Officer. For reimbursement seller has to submit proof of payment to Inspection Agency.

Seller/OEM shall send a notice in writing / e-mail to the Inspecting officer / inspection agency specifying the place of inspection as per contract and the Inspecting officer shall on receipt of such notice notify to the seller the date and time when the stores would be inspected. The seller shall, at his own expenses, afford to the Inspecting officer, all reasonable facilities as may be necessary for satisfying himself that the stores are being and or have been manufactured in accordance with the technical particulars governing the supply. The decision of the purchaser representative / inspection authority regarding acceptance / rejection of consignment shall be final and binding on the seller.

The Seller shall provide, without any extra charge, all materials, tools, labour and assistance of every kind which the Inspecting officer may demand of him for any test, and examination, other than special or independent test, which he shall require to be made on the seller's premises and the seller shall bear and pay all costs attendant thereon.

The seller shall also provide and deliver store / sample from consignment under inspection free of charge at any such place other than his premises as the Inspecting officer may specify for acceptance tests for which seller/OEM does not have the facilities or for special/ independent tests.

In the event of rejection of stores or any part thereof by the Inspecting officer basis testing outside owing to lack of test facility at seller's premises, the seller shall, on demand, pay to the buyer the costs incurred in the inspection and/or test. Cost of test shall be assessed at the rate charged by the Laboratory to private persons for similar work.

Inspector shall have the right to put all the stores or materials forming part of the same or any part thereof to such tests as he may like fit and proper as per QAP/governing specification. The seller shall not be entitled to object on any ground whatsoever to the method of testing adopted by the Inspecting officer.

Unless otherwise provided for in the contract, the quantity of the stores or materials expended in test will be borne by seller.

Inspecting officer is the Final Authority to Certify Performance / accept the consignment. The Inspecting officer's decision as regards the rejection shall be final and binding on the seller.

The seller shall if so required at his own expense shall mark or permit the Inspecting officer to mark all the approved stores with a recognised Government or purchaser's mark.

### 1. Generic

2. If defying the norms as per the Contract a legal action may be taken against me as per the existing Rules.

### 2. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 50 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 50% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

### 3. Scope of Supply

Scope of supply (Bid price to include all cost components) : Only supply of Goods

### 4. Warranty

Timely Servicing / rectification of defects during warranty period: After having been notified of the defects / service requirement during warranty period, Seller has to complete the required Service / Rectification within 15 days time limit. If the Seller fails to complete service / rectification with defined time limit, a penalty of 0.5% of Unit Price of the product shall be charged as penalty for each week of delay from the seller. Seller can deposit the penalty with the Buyer directly else the Buyer shall have a right to recover all such penalty amount from the Performance Security (PBG). Cumulative Penalty cannot exceed more than 10% of the total contract value after which the Buyer shall have the right to get the service / rectification done from alternate sources at the risk and cost of the Seller besides forfeiture of PBG. Seller shall be liable to re-imburse the cost of such service / rectification to the Buyer.

### 5. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the

Bid document, ATC and Corrigendum if any.

#### 6. **Certificates**

### **Pre-Qualification Criteria:**

Prequalification criteria is mandatory to be fulfilled by every bidder. Any offer not fulfilling prequalification criteria is liable to be rejected outright. **The bidder must submit details of its plant machinery/ manufacturing facilities with documentary proof to establish the legal ownership**, thereof, to ascertain that the bidder fulfills the prequalification criteria. OFK reserves the right for physical verification of bidder's capability/manufacturing facility to meet the prequalification criteria.

Pre-qualification criteria is mandatory for all bidders, there is no exception/waived of the same.

- i. If , The Vendor, applying for registration / or participating in advertised tender is manufacturer of 32 mm Steel rod for Shell of 30 mm APT/HEI/HET , it must have following core area facility:
  - a. Electric Arc Furnace (EAF) / Basic Oxygen furnace (BOF) or other Equivalent furnace with similar Function / (electric Induction Furnace + Ladle Refining Furnace).
  - b. Vacuum degassing (VD/VOD).
  - c. Down pour or continuous Casting facility.
  - d. Bar rolling facility or MOU with other firm for the same.

- e. In-house or hired facility for 100 % Ultrasonic test of each bar.
- f. Size of One Heat should be minimum 5 tons.

The minimum average annual financial turnover of the bidder during the last 03 years, ending on 31 March of the previous financial year, should be minimum Rs. 18 lakh (approx). Document evidence in the form of certificate audited balance sheets of relevant periods or a certificate from the chartered accountant/cost accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of Constitution/incorporation of the bidder is less than 03 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for these criteria.

Bidder will have to submit balance sheet and income statement for last 03 year for proving the same.

Firm should have successfully supplied tender item or similar of Steel alloy, bars of qty. at least **50 tons** in last 05 years. In case any conflict with GeM Condition, Buyer added text condition of TE will supersede.

### **Other conditions:**

(i) Contract shall be awarded to only such sellers, who are registered/empanelled/approved/enlisted with OFK or MIL group of factories/erstwhile OFB (through link-<http://ddpdoo.gov.in/vendor/login>) for the required goods or similar category of items i.e. Steel alloy, bars. (if not already registered), are advised to get themselves registered with the said registration authority. It shall be mandatory for the bidders meeting pre-qualification criteria to submit VRRF and Fees for registration, if not already registered.

(iii) Bidders to submit the compliance statement duly filled and signed by firm as per format uploaded along the tender.

iv) OFK reserves the right to witness the manufacturing of the subject item or similar of Steel alloy, bars. Firm should intimate OFK prior to starting the manufacturing of the Tendered item.

(v) Firm should have successfully supplied tender item or similar of Steel alloy, bars, to any Central/State Govt. Organization/PSU/Public listed Company. In case any conflict with GeM CONDITION, Buyer added text condition of TE will supersede.

(vi) If any firm submit online VRRF form(through link-ddpdoo.gov.in /vendor/login) before bid opening date with relevant fees and documents & the firm is found otherwise eligible for registration by registering agency then the offer of that firm/firms may also be considered for further evaluation. However firms must attach a copy of submitted VRRF & Fees along with its bid before tender opening date & time. Any offer without copy of valid registration certificate (VRRF & Fees) shall be liable to be rejected.

(vii) Firm has to submit Earnest Money Deposit as Bid security as mentioned in TE along with the Tender in favor of “ GENERAL MANAGER, ORDNANCE FACTORY KHAMARIA, JABALPUR “as per GEM terms & conditions. EMD is to be submitted by the bidders except Micro and Small Enterprises (MSEs) having UAM number as defined in MSE Procurement Policy 2012 issued by Department of Micro, Small and Medium Enterprises (MSME) or are registered with the Central Purchase Organisation or the concerned Ministry or Department (including OFs) or Start-ups as recognised by Department of Industrial Policy and Promotion (DIPP), irrespective of the store for which they are registered.
