If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 100%(selected by Buyer) percentage of total QUANTITY. Traders are excluded from the purview of public procurement policy for micro & small enterprises. Relevant documentary evidence in this regard shall be uploaded along with the bid. If LI-1 is not an MSE & MSE seller(s) has/have quoted price within L-1 + 15% of margin of purchase preference / price band defined in relevant policy, such seller shall be given opportunity to match L-1 price and contract will be awarded for __100__ percentage of total quantity. Benefits of public procurement policy shall be given to all eligible MSEs as stated under point no.3 of FAQ dt. 25.03.2022, irrespective of product categories and the category they are registered under viz. manufacturing or service.
