### Terms and Conditions

-

1. Rate quoted by bidder / firm for each analytical gas should include both Transportation and Handling charges. No separate charges for Transportation and handling charges at both sites will be entertained.

2. Firm must have the authorization/ Certificates to supply & Distribute the analytical gases from the recognized analytical gas Manufacturer/ Supplier/ Agency.
3. Rates should be quoted for supply of gases in firms own gas cylinders for items except for items S.No: 05 (P10 Gas) & S.No: 06 (Helium Gas). For these two gases the supply has to be made in GSI's cylinders. GSI's empty cylinders (P10 and He gas) taken by the firm for refilling should be returned to GSI within 15 Days.
4. Normally the cylinders after use will be returned to the firm for refiling within one month from date of receipt of filled cylinder. No rent or holding charges will be paid by GSI for the cylinders.
5. Payment for the satisfactory supply of gases will be made on monthly / bi monthly basis.
6. No security money will be paid by GSI to the firm for the Gas cylinders of the firm.
7. Unloading and loading of cylinders at Suppliers workshop/ site shall be arranged by supplier itself.
8. Unloading / loading of cylinders at GSI premises & transportation to Chemical division, GSI, SR, Hyderabad shall be arranged by Supplier itself.
9. Certificate of Purity with cylinder number along with the weight of the gas and pressure of the cylinder shall be submitted at the time of delivery of cylinder. In case of any deviation in terms of Quality & Quantity the supplied cylinders should be replaced immediately otherwise the contract will be cancelled.
10. The quantity of the gases mentioned in Annexure-A is tentative. The required quantity may vary depending upon the actual requirement.
11. The firm should maintain sufficient stock & execute the supply of gases periodically (every fortnight) as per the monthly requirement mentioned in Annexure -A, the requirement of the gases shall be conveyed by GSI from time to time by email/ phone/ fax.
12. In case of emergency the firm should be able to supply 06 cylinders of Argon (S.No: 1) and 01 cylinder each from other categories (S.No: 02 to 06) within 03 days of intimation of such requirement.
13. Scope of supply: Material shall be supplied as per the applicable latest standards as mentioned in Annexure-A. In case of any revision, amendment or special requirement, the material shall be supplied as per mutual agreement.
