Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Scope of supply (Bid price to include all cost components) : Only supply of Goods

**2. OEM**

IMPORTED PRODUCTS: In case of imported products, OEM or Authorized Seller of OEM should have a registered office in India to provide after sales service support in India. The certificate to this effect should be submitted.

**3. Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

**4. Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

1) Subject GEM Bid has been floated on Original Equipment Manufacturer (OEM)/Original Equipment Supplier (OES) who has handled the original supply , installation of the equipment at NTPC.

2) OEM/OES for this Tender is

Accordingly, OEM is only eligible to participate in this Bid.

3) OEM is preferably requested to participate in the Bid directly without Channel Partner/ Dealer.

4) In case, OEM intends to participate through their authorized Dealer, then OEM shall issue a Bid specific authorization in favour of authorized Dealer. General Authorization letter is not acceptable.

5) OEM shall nominate only one dealer against this GeM Bid. Multiple Dealer authorizations is strictly not permitted.

6) OEM authorized Dealer shall ensure to submit the Bid specific Authorization letter issued by OEM, along with their Bid documents.

7) Bid Documents received without Bid specific Authorization letter, shall be rejected. Further, if bid is received with general authorization letter, the same shall not be considered and their Bid summarily rejected. No claim, of whatsoever kind, shall be entertained later in this regard.

8) If OES(if applicable) is participating in the bid, then they have to participate directly and not through dealer.

9) Being ST-OEM/OES case MSE clause is applicable among the OEM & OES vendors.

10) **Inspection:** Receipt inspection at NTPC Stores.

11) Certificates/ documents to be submitted:

1. The ordered materials shall be guaranteed towards bad workmanship/ faulty materials for a period of 12 months from the date of use or 18 months from the date of despatch, whichever is earlier. This condition is binding, however there is no requirement of submission of guarantee/warranty certificate along with supply
2. The supplied items shall be interchangeable with existing spares/ items at Ntpc. This condition is binding, however there is no requirement of submission of interchangeability certificate along with supply.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
