1. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023.

2. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY. 1. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- Please do not disclose price related information in the Technical part otherwise your offer will be considered as invalid and will be rejected.
- Delivery Schedule:** Vendor shall deliver the instruments/equipment within 90 days from the date of PO.
- Warranty:** 05 Years warranty from the date of final acceptance of systems by IN-SPACe. During warranty period, if system or any subsystem stops working partially or fully, it shall be the responsibility of supplier to make it fully operational at no extra cost. Warranty and post warranty Service and spares support should be available for minimum 5 years after th

e completion of warranty period. *Vendor shall submit Warranty Certificate along with supply.*

4. **TERM OF PAYMENT:** 100% payment shall be released after installation, demonstration and acceptance of the Instruments with all the option/s at buyer site.
5. **Liquidated Damages:** If the vendor fails to execute the order within the time specified in the order or any extension thereof, buyer shall recover from the supplier as liquidated damages a sum of one half percentage (0.5%) for the undelivered portion of the contract value per calendar week of delay and part thereof. The total liquidated damages shall not exceed Ten percent (10%) of the contract value. The delivery schedule stipulated in the order/contract will be the essence of the contract.
6. Buyer will not be responsible for any contingency arising out, while executing the contract, inside or outside the IN-SPACE premises. The contractor will be responsible for the safety of his work force. Buyer shall not be responsible for any accident/injury/loss of life of Service unit due to natural calamities, accidents etc. The contractor shall abide to indemnify buyer from any claims that may be filed by his work force. Contractor shall adequately insure his work force against accidents/loss/injury/ including loss of life if any that may arise during their work.
7. **Safety:** The contractor shall train their workers on safety related aspects and implementation of safety precautions/procedures at work site is the responsibility of the contractor. The contractor and his workers shall abide all the safety regulations during the work.
8. Detailed Specifications, Terms and conditions will be as per attached Request for Proposal (RFP).

2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.

12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
