Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY. The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017.

Buyer Added Bid Specific Terms and Conditions/क्रेता द्वारा जोड़ी गई बिड की विशेष शर्तें

1. Scope of Supply

Scope of supply (Bid price to include all cost components) : Only supply of Goods

2. Generic

Experience Criteria: The Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for 1 year before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the year. In case of bunch bids, the primary product having highest value should meet this criterion.

3. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 50 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 50% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

4. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. **Delivery Condition:-**

(a) Consignee Unit: Consignee Unit is 1034 (I) ESPL (GREF), Leh.

(b) Delivery time : Delivery should be completed within 15 days from the date of placing of GeM contract.

2. **Document Required**: The under mentioned documents should be submitted by sellers in T-Bid:-

- (a) Experience for similar nature of printed form/item.
- (b) ATC Certificate duly accepted all terms and condition.

3. **Sample Card** : Successful bidder will ensure to print and supply the Health Card same as per buyer requirement. Health cards should be properly laminated with duly colored logo & text of cover page and having good paper quality. Health Cards if supplied other than sample will not be acceptable.

4. **Option Clause**: The Purchaser reserves the right to increase or decrease the quantity to be ordered upto 50 % at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by upto 50% of the contra

cted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

5. **Cancellation of Bid:** Competent Authority will have the right to cancel the bid at any stage of procurement process including after opening of financial bid and Reverse Auction without assigning any reason to seller. No representation will be entertained in this regards.

6. **Inspection of Stores:** The supplied stores to be checked by a Technical Board of Officer detailed by competent authority.

7. **Rejected Stores:** All rejected stores are liable to be back loaded by seller within seven days from consignee location at own risk and cost in case of stores not accepted by TBOO.

8. **Liquidated Damages:** If the Stores are not supplied within the stipulated period/time limit as specified, a penalty of 0.50% per week or not exceeding 10% of the total cost of the GeM order will be levied for late supply.

9. **Sellers Past Performance Criteria In CE (P) Himank/755 BRTF:** If any seller has awarded GeM contract by HQ CE(P) Himank/755 BRTF in earlier and found pending for completion or supply store partially even lapse of delivery date or GeM contract cancelled due to non supply of stores, such seller not to be considered to be qualify in T-Bid evaluation. No representation in this regards will be entertained.

10. **Payment terms &Condition:** Payment will be released after 100% supply of items as per GeM Terms & Conditions.

11. **Payment Authority:** PCDA (BR), New Delhi.

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.

10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
