4. The minimum local content to be considered as a Class 1 local supplier is denoted in the bid document. 8. 2. **Delivery Period.** Delivery period for supply of item would be **180 Days** from the date of award act. For the clause '**Advance Sample**', time taken in clearance of advance sample will be included in the delivery period.

3. **Earnest Money Deposit.** Bidders are required to submit Earnest Money Deposit (EMD) for fixed amount of **Rs 98174/-** along with their bids. The BUYER may deduct from the SELLER as agreed, liquidated damages to the sum of 0.5% of the contract price of the delayed/undelivered stores/ services mentioned above for every week of delay or part of a week, subject to the maximum value of liquidated Damages being not higher than 10% of the value of delayed stores.

12. **Termination of Contract.** The Buyer shall have the right to terminate this Contract in part or in full in any of the following cases:-

(a) The delivery of the material is delayed for causes not attributable to Force Majeure after the scheduled date of delivery.

(b) The Seller is declared bankrupt or becomes insolvent.

(c) The Buyer has noticed that the Seller has utilised the services of any Indian/ Foreign agent in connection with his contract and paid any commission to such individual/ company etc.

(d) As per decision of the Arbitration Tribunal.

(e) **Contract can be cancelled (fully/ partly)** unilaterally by the buyer in case items are not received within the contracted delivery period. Extension of contracted delivery period will be at the sole discretion of the buyer, with applicability of LD clause.

(f) In case of any forged documents/ any form of corruption/ prejudiced dealing during the validity of the contract, the contract will be terminated immediately. Action against the bidder/ seller in consonance with the provisions of COA 2009 & GFR 2017 will be followed.

13. **Tolerance Clause.** To take care of any change in the requirement during the period starting from the issuance of bid documents till award of the contract, Buyer reserves the right to 25% plus/minus increase or decrease the quantity of the required goods up to that limit without any change in the terms & conditions and prices quoted by the bidder. While awarding the contract, the quantity ordered can be increased or decreased by the Buyer within this tolerance limit.

14. **Inspection Authority.** The inspection will be carried out by constituted Bd of Officers by the Buyer.

15. **Warranty.** Except as otherwise provided in the invitation tender, the seller hereby declares that the goods, stores articles sold/supplied to the Buyer under this contract shall be of the best quality and workmanship and shall conform to the specifications mentioned in the bid documents.

in all respects and shall be strictly in accordance with the specification and particulars contained/mentioned in the contract. The Seller hereby guarantees that the said goods/ stores/ articles would continue to conform to the described quality aforesaid for a period of 12 months from the date of delivery of the said goods/stores/ articles to the buyer or 15 months from the date of shipment/dispatch from the Seller's or standard warranty period as given by the manufacturer whichever is of a longer period.

16. **Correctness of the Quality and Quantity.** On receipt of stores at consignee's premises at CASD Dutt, the stores are checked for ascertaining the correctness of quality, quantity and document. In case the stores are found deficient in any way, the consignee has the right to reject the stores even if these were inspected and cleared by the inspector.

17. The supplier shall be responsible for the safe delivery of the stores at the consignee's end and transit if any shall be promptly attended by him.

18. **Transportation.** Stores in good condition will be delivered free at consignee premises at CASD Dutt-10.

19. **Performance security/ PBG.**

(a) **For Indigenous cases.** After award of contract, the bidder will be required to furnish Performance Guarantee by way of Bank Guarantee through a public sector bank or a private sector bank authorized to conduct government business (SBI, ICICI Bank Ltd., Axis Bank Ltd or HDFC Bank Ltd.) for a sum equivalent to **% of the contract value within 30 days** of receipt of the confirmed order. If the PBG is not received within 30 days from the date of placement of Supply Order, the contract can be cancelled unilaterally by the Purchaser. The Performance Bank Guarantee should be valid up to 60 days beyond the date of warranty. The specimen form is given in Form DPM-15 (Available in MoD website and can be provided on request). **In the event of re/breach of contract PBG will be forfeited in order to compensate the loss to the buyer.**

20. **Option Clause.** Under this clause, the Purchaser retains the right to place orders for additional quantity up to a maximum of **50%** of the originally contracted quantity at the same rate and terms of the contract. This option is available during the original period of contract provided this clause had been incorporated in the original contract with the supplier. Option quantity during extended DP is to be limited to 50% of balance quantity after original period. This clause may be exercised in case of procurement from single vendor/OEM also subject to there being no downward trend in prices.

21. **Force Majeure clause.**

(a) Neither party shall bear responsibility for the complete or partial non-performance of any of its obligations (except for failure to pay any sum which has become due on account of receipt of goods under the terms of the present contract), if the non-performance results from such Force Majeure circumstances as War, Fire, Earth Quake and other acts of God as well as War, Military operation, blockade, Acts or Actions of Government Authorities or any other circumstances beyond the parties control that have arisen after the conclusion of the present contract.

(b) In such circumstances the time stipulated for the performance of an obligation under the present contract is extended correspondingly for the period of time of action of these circumstances and their consequences.

(c) The party for which it becomes impossible to meet obligations under this contract due to Majeure conditions, is to notify in written form the other party of the beginning and cessation of the circumstances immediately, but in any case not later than 10 (Ten) days from the moment of their beginning.

(d) Certificate of a Chamber of Commerce (Commerce and Industry) or other competent authority of the respective country shall be a sufficient proof of commencement and cessation of the circumstances.

(e) If the impossibility of complete or partial performance of an obligation lasts for more than 6 (six) months, either party hereto reserves the right to terminate the contract totally or partially upon giving prior notice of 30 (thirty) days to the other party of the intention to terminate without any liability other than reimbursement on the terms provided in the agreement for the goods received.

## 22. **Responsibility of the Contractor for Executing Contract.**

(a) **Risk in the Store.** The contractor shall perform the contract in all respects in accordance with the terms and conditions thereof. The store and every constituent part thereof, whether in the possession of the Contractor, his agents or servants or a carrier or in the joint possession of the Contractor and his servants shall remain in every respect at the risk of the Contractor until their actual delivery to the consignee at the stipulated place or destination or where so provided in the contract until delivery to the person named in the schedule as interim consignee for the purpose of dispatch to the consignee. The Contractor is responsible for the loss, destruction, damages or deterioration of or to the stores from any cause whatsoever while the store after approval by the inspector are awaiting dispatch or delivery or are in the course of transmission to the consignee. The Contractor shall alone be entitled and responsible to make claims against Railway administration or other carrier in respect of non delivery short delivery, miss-delivery, loss or destruction damage or deterioration of the goods entrusted to such carrier by the contractor for transmission to the consignee or interim consignee as the case may be.

(b) **Consignee Right of Rejection** Notwithstanding any approval which the Inspector may give in respect of any part or portion thereof or any materials or other particulars or the works of work involved in the performance of the contract (whether with or without any test carried out by the contractor or the Inspector or under the directions of the Inspector) and notwithstanding delivery of the stores when provided to the interim consignee, it shall be lawful for the consignee, on behalf of the purchaser to reject the stores or any part or portion or consignment thereof within 45 days after actual delivery thereof to him reckoned from the date of receipt of complete equipment with spare and accessories as ordered if such stores or portion or consignment thereof is not in all respects in conformity with the terms and conditions of the contract whether on account of any loss, deterioration or damage before dispatch or delivery or during transit or otherwise however.

(c) Provided that where, under the terms of the contract the stores are required to be delivered to the interim consignee for the purpose of dispatch to the consignee the stores shall be at the purchaser's risk after delivery to the consignee, but nevertheless it shall be lawful for the consignee on behalf of the purchaser to reject the store or any part, portion or consignment thereof upon their actual delivery to him at the destination if they are not in all respects in conformity with the

term and conditions of the contract except where they have been damaged or have deteriorated in th or otherwise after their delivery to the interim consignee.

23. **Fall clause.** The following fall clause will form part of the contract placed on successful Bidder:-

(a) The price charged for the stores supplied under the contract by the Seller shall in no event be the lowest prices at which the Seller sells the stores or offer to sell stores of identical description to any / Organisation including the purchaser or any department of the Central government or any Departmente government or any statutory undertaking the central or state government as the case may be during the period of the Supply Order.

(b) If at any time, during the said period the Seller reduces the sale price, sells or offer to sell such to any person/ organization including the Buyer or any Department, of central Govt. or any Departmente State Government or any Statutory undertaking of the Central or state Government as the case may be at a price lower than the price chargeable under the contract, the seller shall forthwith notify such reduction or offer of sale to the Director General of Supplies & Disposals and the price payable under the contract for the stores of such reduction of sale or offer of the sale shall stand correspondingly reduced. The above provision will, however, not apply to:-

(i) Exports by the Seller.

(ii) Sale of goods as original equipment at price lower than the prices charged for normal equipment.

(iii) Sale of goods such as drugs which have expiry dates.

(iv) Sale of goods at lower price on or after the date of completion of sale/ placement of the goods by the authority concerned under the existing or previous Rate Contracts as also under previous contracts entered into with the Central or State Government Departments, including undertakings excluding joint sector companies and/or private parties and bodies.

24. **Risk & Expense clause**

(a) Should the stores or any installment thereof not be delivered within the time or times specified in the contract documents, or if defective delivery is made in respect of the stores or any installment thereof, the Buyer shall after granting the Seller 45 days to cure the breach, be at liberty, without prejudice to the right to recover liquidated damages as a remedy for breach of contract, to declare the contract as cancelled either wholly or to the extent of such default.

(b) Should the stores or any installment thereof not perform in accordance with the specifications and standards provided by the SELLER during the check proof tests to be done by the BUYER in the prescribed manner, the BUYER shall be at liberty, without prejudice to any other remedies for breach of contract, to cancel the contract wholly or to the extent of such default.

(c) In case of a material breach that was not remedied within 45 days, the BUYER shall, having given notice of first refusal to the SELLER be at liberty to purchase, manufacture, or procure from any other source the goods he thinks fit, other stores of the same or similar description to make good:-

(i) Such default.

(ii) In the event of the contract being wholly determined the balance of the stores remain delivered there under.

(d) Any excess of the purchase price, cost of manufacturer, or value of any stores procured from er supplier as the case may be, over the contract price appropriate to such default or balance shall be rable from the SELLER. Such recoveries shall not exceed 100% of the value of the contract.

25. **Payment Terms.** It will be mandatory for the Bidders to indicate their bank account numbers and relevant E-payment details. A copy of the model mandate form prescribed by RBI to be submitted

by Bidders for receiving payments through ECS is at Form DPM-11 (Available in MoD website and can be given). The payment shall be made on delivery and acceptance of the stores by the buyer.

26. **Part-Dispatch/ Part-Shipment.** Part-dispatch or part-shipment of goods is permitted and correct payment will be released to the SELLER after accepting stores post inspection.
