1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up

to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. **Generic**

Bidder shall submit the following documents along with their bid for Vendor Code Creation:

- a. Copy of PAN Card.
- b. Copy of GSTIN.
- c. Copy of Cancelled Cheque.
- d. Copy of EFT Mandate duly certified by Bank.

3. **Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

1. For Maintaining requisite genuine product an advance sample should be reached to this location before one day prior of opening of tech bid by all participant.
2. Product warranty/Guarantee Certificate are must reqd from seller duly signed with stamp.
3. In Case sample not recd from any bidder on one day before of opening on technical bid, the bid of the vendor will be rejected.
4. Sample of Product will be inspected at consignee location.
5. All documents which are required for subject for tender must be uploaded by seller.
6. Bid will be rejected in case any faulty/incorrect documents are uploaded at any stage.
7. All items are urgent required for smooth functioning to our location.
