1. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY. The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017.

**ITEM ACCEPTANCE CRITERIA FOR ITEM NO.1**

At supplier's site:

- 1) The system shall be checked with respect to all the tender specifications.
- 2) The system shall be tested with a granulated powder (testing material) having bulk density of at least 2.7 g/cc and Mohs scale hardness of at least 5. Total 5 trials will be carried out on the granulated powder and it should be able to quantify the friability of the granules with an accuracy of +/- 1%

3) Testing material is in the scope of supplier

At NFC:

- 1) The system shall be checked for any visual/functional damages.
- 2) Operational and maintenance manual shall be provided.

#### **ITEM ACCEPTANCE CRITERIA FOR ITEM NO.2**

At supplier's site:

- 1) The system shall be checked with respect to all the tender specifications.
- 2) The system shall be tested with tablets having density of atleast 5.6 g/cc and dimensions of 15 - 18 mm dia and 16-20 mm height. Total 5 trials will be carried out on the tablets provided and it should be able to quantify the friability of the tablet with an accuracy of +/- 1%
- 3) Testing tablets is in the scope of supplier.

At NFC:

- 1) The system shall be checked for any visual/functional damages.
- 2) Operational and maintenance manual shall be provided.

#### **Vendor Evaluation Criteria (for item 1 & 2)**

The supplier shall be an original manufacturer/authorized dealer of granule/tablet friability meter. To prove the same he shall submit the following along with the offer:

- 1) In case of original manufacturer, documentary evidence supporting the same shall be submitted. In case of dealer, the supplier shall submit the authorization/dealership certificate along with the original manufacturer's documentary evidence.
- 2) The catalogue of the quoted model no. and technical specifications of the item shall be submitted, otherwise the bidder will be technically rejected.
- 3) The supplier shall submit a PO copy (of granule or tablet friability meter) executed by him in the last 5 years from the date of tender. Completion certificate (like delivery challan, tax invoice etc.) for the same shall also be submitted along with the offer.

#### **IMPORTANT NOTES FOR BIDDERS**

a) Bidder shall furnish Land boarder certificate enclosed herewith without fail, without which your offer shall not be considered for evaluation.

#### **DELIVERY INSTRUCTIONS:**

- a) Stores are to be delivered to the Store Keeper (Receipt and Inspection) at the place of delivery stipulated in the Contract between 10.30 a.m. and 3.00 p.m. on working days.
- b) No stores shall be accepted by the Store keeper (Receipt and Inspection) unless delivery challan giving full details of the Contract Number and Date and Description of Stores, Quantity, Make, Unit, Gross Weight Tare Weight are submitted with the stores. In the absence of any of the above, the Store Keeper (Receipt and Inspection) shall refuse to take delivery of the stores. The supplier should submit the warranty/ guarantee card/certificate along with the Delivery Challan in whichever case it is applicable while effecting delivery of item.

c) A receipt for the packages only and not for the contents will be given by our Central Stores initially. The Suppliers are advised to properly seal the package. Final receipt will be given from the Central Stores, after inspection.

Driver's Note: The drivers, while bringing the material in motor vehicles into NFC premises, shall carry their respective original driving license to facilitate security checks properly before entering inside NFC premises without any delay.

In case the contractor is unable to deliver the goods within the delivery schedule stipulated in this Contract, it is mandatory on his part to approach the purchaser for extension of the delivery date with justification for the delay for consideration of the purchaser.

The contractor should deliver the goods only after getting the delivery period extended by the purchaser. In case the contractor fails to adhere to this condition and deliver the goods to the consignee after expiry of the delivery date without getting the delivery period extended, it is not only that the consignee will not receive the goods dispatched by the suppliers but the bills if any furnished by the contractor will be rejected without any liability and obligation on the part of the Purchaser.

This will not in any way prejudice the other rights of the purchaser under the terms and conditions of the Contract.

### 3. Inspection

**Pre-dispatch inspection at Seller premises (Fee/Charges to be borne by the BUYER):** Before dispatch, the goods will be inspected by Buyer / Consignee or their Authorized Representative or by Nominated External Inspection Agency (independently or jointly with Buyer or Consignee as decided by the Buyer) at Seller premises (or at designated place for inspection as declared / communicated by the seller) for their compliance to the contract specifications. Fee/Charges taken by the External inspection Agency and any external laboratories testing charges shall be borne by the Buyer. For in-house testing, the Sellers will provide necessary facilities free of cost. Seller shall notify the Buyer through e-mail about readiness of goods for pre-dispatch inspection and Buyer will notify the Seller about the Authorized Representative/ Nominated External Inspection Agency and the date for testing. The goods would be dispatched to consignee only after clearance in pre-dispatch inspection. Consignee's right of rejection as per GTC in respect of the goods finally received at his location shall in no way be limited or waived by reason of the goods having previously been inspected, tested and passed by Buyer/ Consignee or its Nominated External Inspection Agency prior to the goods' shipment. While bidding, the sellers should take into account 7 days for inspection from the date of email offering the goods for inspection. Any delay in inspection beyond 7 days shall be on the part of the buyer and shall be regularised without Liquidated Damages.

When there is requirement of submission the advance sample, the seller shall inform the buyer promptly through emails about the date of submission of sample to the buyer nominated Inspection agency.

## Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to

exemption provided to such sellers under GeM GTC.

3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
