1. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY. 3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Forms of EMD and PBG

WARRANTY /GUARANTEE: The supplier shall give a warranty of satisfactory performance of spares supplied for a period of 12 months from the date of fitment or 18 months from the date of acceptance of material at consignee's end, whichever is earlier.

Eligibility Criteria:

The bidder should be **OEM / OES / OPM** of the tendered items or their sole selling agent / authorized dealer / distributors with 1:1 fitment guarantee.

(A) OEM (i.e. M/s KOMATSU) : - Means Original Equipment Manufacturer

(B) OES (M/s LARSEN & TOUBRO LIMITED) : - Means authorized supplier of original equipment manufacturer. Only those firms who have the current authorization and /or technical collaboration of OEM for supply of their equipment and giving technical services would be treated as OES. T

he OES who may not have current authorization/collaboration of OEM but have already developed and indigenized fully or partly the spares for the equipments supplied by them may also be considered to have OES status to such an extent of developed/indigenized spares.

(C) OPM : - Means original part manufacturer falling under the following categories:

The original manufacturers of assemblies, sub-assemblies or components of original equipment.

The original manufacturer of spares parts / items of assemblies, sub-assemblies or components of the original equipment.

The status of a manufacturer as OPM will be determined on fulfilling **any one** of the following criteria :

(1) On submission of the following documents by OPM:

(a) Self-certificate, of being manufacturer of the Assemblies / Sub-assemblies / Components etc..

(b) Self-certified copies of Purchase Orders in support of proof of having supplied to OEM or copy of Agreement of the OEM with OPM, for the tendered items.

(c) Self-certified copy of performance Certificate from the end user to assess the proven-ness credibility of the OPM based on the following criteria:

“Assemblies/sub-assemblies/components and their spares etc. offered by OPM must have been supplied in the past to CIL / Subsidiaries Companies or other PSUs / Government department and these should have performed satisfactorily for a period of not less than one year from the date of fitment / commissioning”

If the above mentioned declaration / information /documents submitted by the OPM are subsequently found false or forged / tampered in any way, the total responsibility shall lie with the OPM and CIL / subsidiaries companies shall reserve the full right to take suitable penal action as may be deemed fit including banning of business, apart from forfeiture of EMD, Security Deposit etc.

OR

(2) The manufacturer whose supplied assemblies /sub-assemblies /components to the OEM, have been declared fitted on the equipment by the OEM. In such case documents mentioned under 1(a), 1(b) and 1(c) above are not required for declaring them as OPM.

OR

(3) The manufacturer whose supplied assemblies / sub-assemblies / components were found fitted on the equipment at the time of physical verification by the committee. In such cases documents mentioned under 1(a), 1(b) and 1(c) above are not required for declaring them as OPM.

Once OPM has been identified, no documents related to the identification are required to be submitted by the OPM in each separate procurement case.

If the OPM does not supply directly to CIL as a matter of corporate policy, it may nominate distributor / dealer / agent for a particular subsidiary company and on such authorization, procurement may be made from such authorized distributor / dealer / agent.

In case, any specific purchase order(s) has/have not been fully executed and any complaint /claim is pending, then details of such cases to be categorically mentioned with the reasons thereof so that decision making is in clear perspective without any hidden facts in the subject matter.

The authenticity of the self-certificate as well as other documents submitted/uploaded by the bidder will solely be their responsibility and appropriate action will be taken by CIL / Subsidiary Company if it is subsequently found to be misleading / false / forged.

However, SECL reserve the right to verify the above or get performance directly from the concerned buyers /customers /end users of the items supplied by the bidders against supply order.

SOLE SELLING AGENT / AUTHORIZED DEALER / DISTRIBUTORS ARE REQUIRED TO SUBMIT FOLLOWING DOCUMENTS:

Sole selling agent / authorized dealer / distributor will submit specific authorization letter from their principal to quote against the tender. The authorization letter duly notarized & self attested for specific tender should be submitted along with their offer by the firm quoting on behalf of their principal. In case they quote on behalf of proven manufacturer then they should submit copy of registration certificate of their principal as a proof of manufacturer and submit all the documents regarding proof of supply of their principal as stated above.

Sole selling agent/authorized dealer/distributor participating in the tender on behalf of one manufacturer will not be allowed to quote on behalf of another manufacturer along with the first manufacturer.

All documents as stated above should be duly self-authenticated & notarized and should be submitted along with its on-line required documents in Part-I bid.

Failure to submit the above documents may render a tender unacceptable.

8. Warranty

Warranty period of the supplied products shall be as given in specifications from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after

12. **Warranty**

Timely Servicing / rectification of defects during warranty period: After having been notified of the defects / service requirement during warranty period, Seller has to complete the required Service / Rectification within 15 days time limit. If the Seller fails to complete service / rectification with defined time limit, a penalty of 0.5% of Unit Price of the product shall be charged as penalty for each week of delay from the seller. Seller can deposit the penalty with the Buyer directly else the Buyer shall have a right to recover all such penalty amount from the Performance Security (PBG).Cumulative Penalty cannot exceed more than 10% of the total contract value after which the Buyer shall have the right to get the service / rectification done from alternate sources at the risk and cost of the Seller besides forfeiture of PBG. Seller shall be liable to re-imburse the cost of such service / rectification to the Buyer.

13. **Generic**

While generating invoice in GeM portal, the seller must upload scanned copy of GST invoice and the screenshot of GST portal confirming payment of GST.
