2) **Payment Timelines**: Payments shall be made to the Seller within 21 days of issue of consignee receipt-cum-acceptance certificate (CRAC) and on-line submission of bills (This is in supersession of 10 days' time as provided in clause 12 of GeM GTC).

3) The bidders **are not required to submit EMD** against this GEM Bid. However, **Bid Security Declaration is applicable in this tender**. Bidders are requested to Submit the same in **Proforma-O** attached herewith.

4) Bidders are requested to submit all the Proformas as per the requirement of the GEM bid.
