1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Scope of Supply

Scope of supply (Bid price to include all cost components) : Only supply of Goods

3. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

4. Generic

Bidder shall submit the following documents along with their bid for Vendor Code Creation:

- Copy of PAN Card.
- Copy of GSTIN.
- Copy of Cancelled Cheque.
- Copy of EFT Mandate duly certified by Bank.

5. Generic

Supplier shall ensure that the Invoice is raised in the name of Consignee with GSTIN of Consignee only.

6.Delivery period and Schedule: Delivery to be completed preferably within 6 months from award. However, the vendor must endeavour to supply material at the earliest.

2) Authorized dealers of OEM may also participate in the bid provided they have the valid authorization from the OEM for the particular tender. Authorized dealer / Channel Partner shall attach the Authorization Certificate / Confirmation from the OEM along with the bid documents as proof of authorization.

3) Bid submitted by vendor other than OEM/Channel Partner/Authorized dealer shall be liable for rejection.
