The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. Bidders shall thoroughly go through the Instruction to Bidders and Scope of work.
2. All declarations as per Instruction to Bidders (ITB) shall be submitted.
3. While bidding price in tender, it shall be inclusive of all taxes and duties.
4. Bidder shall submit signed copy of BPCL Social Media Policy as acceptance of the same.
05. BPCL shall be issue separate PO for invoicing purpose .
06. Successful bidder shall be issued with BPCL contract copy. 07. Scope of work ,ITB and all relevant documents is uploaded in scope of work section. Vendor has to supply the material as per Scope of work and Uploaded BPCL documents only.
08. Successful bidder shall submit MOA on 100 rupees non- judicial stamp paper as per format enclosed in bid document

Disclaimer/अस्वीकरण
