1. Generic

Bidder shall submit the following documents along with their bid for Vendor Code Creation:

- Copy of PAN Card.
- Copy of GSTIN.
- Copy of Cancelled Cheque.
- Copy of EFT Mandate duly certified by Bank.

2. Scope of Supply

Scope of supply (Bid price to include all cost components) : Only supply of Goods

3. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- The Bidder should point wise comply with all the scope of work/enclosed attachment & bid document putting signature and stamp on the bottom left corner of each page and submit with bid, failing to which bid may be rejected.
- Vendors shall be responsible for any deviations in the specifications and also for any damages incurred during transportation.
- The bidders has to comply all the points in the scope of work and a compliance undertaking thereby must be enclosed along with the bid failing to which bid may be rejected.
- The bidders has to provide the brand names in a company letter head with sealed logo & signature failing to which bid may be rejected.
- Only local vendors(hyderabad) are allowed to participate
- All the items should be supplied in proper condition.

7. Arbitration:

- **B) For Defence Psus: The Case Of Arbitration Shall Be Referred To The Secretary Defence (R&D) For The Appointment Of Arbitrator(S) And Proceedings.**

C) For Other Firms: Any Dispute, Disagreement Or Question Arising Out Of Or Relating To The Contract Or Relating To Product Or Performance, Which Cannot Be Settled Amicably, Shall Be Resolved By Arbitration In Accordance With Either Of The Following Provisions:

“The Case Of Arbitration May Be Referred To Arbitrator / Arbitrators Appointed As Per Section 11 Of Indian Arbitration And Conciliation Act, 1996 As Amended And The Proceedings Shall Be Conducted In Accordance With Procedure Of Indian Arbitration And Conciliation Act, 1996 As Amended.”

Or

“The Case Of Arbitration May Be Referred To International Centre For Alternative Dispute Resolution (Icadr) For The Appointment Of Arbitrator And Proceedings Shall Be Conducted In Accordance With Procedure Of Indian Arbitration And Conciliation Act, 1996 As Amended.”

Or

“The Case Of Arbitration May Be Conducted In Accordance With The Rules Of Arbitration Of The International Chamber Of Commerce By One Or More Arbitrators Appointed In Accordance With The Said Rules In India. However, The Arbitration Proceedings Shall Be Conducted In India Under Indian Arbitration And Conciliation Act, 1996 As Amended.”

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
