If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. 5. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

- a) Bidder should be manufacturer of **SKF/FAG (Schaeffler)/TIMKEN** make bearings (or) their authorized dealer/ distributor. Authorized Dealer/ distributor should submit valid authorization certificate from principles along with part-1 of their offer, failing which their offer shall be rejected.
- b) Bidder should submit previous purchase order copies of supply of bearings of make **SKF/TIMKEN/FAG (Schaeffler)** supplied to any company during the last three years ending with last date of previous month on which tender is floated along with part-1 of their offer, failing which their offer shall be rejected.
- c) Bidder should have average annual financial turnover of minimum Rs.5lakhs during the three financial years **2020-2021, 2021-2022, 2022-2023** for which the bidder should submit Audited P & L statement as a proof along with part-1 of their offer. As per ICAI notification all the certificates and audit reports should consist of UDIN generated by the CA, failing which their offer shall be rejected.
