1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY. 1. Scope of Supply

Scope of supply (Bid price to include all cost components) : Supply Installation Testing and Commissioning of Goods

2. Buyer Added Bid Specific ATC

Eligibility Criteria:

1. OEM/authorized dealers of OEM are only eligible to participate. Authorized dealers of OEM are required to submit BID Specific authorization from OEM, else their offer shall be ignored and passed over.

M& P Conditions:

1. Timely Commissioning of M&P /items: Firm to install and commission the machine within the Delivery Schedule (Complete date) as mentioned in the Purchase Order. In the event of contractor's failure to have M&P commissioned by the time or times respectively as specified in contract, consignee to withhold deduct or recover from the contractor as penalty a sum @2% (Two Percent) of the price of M&P which the contractor has failed to commission as aforesaid for each and every month (Part of month being treated as a full month) during which the M&P may not have been commissioned, subject to an upper limit of 10% (Ten Percent) of contract value..

2. Warranty period for shall be as per GeM specification from the date of commissioning and proving out of M P, A maximum period of 02(Two) weeks will be allowed for attending and rectification of faults during the warranty period.

3. Maximum downtime during the guarantee period shall be 2% for online and 10% for offline M P calculated on quarterly basis, in the event of contractor's failure to have M P commissioned by the time or times respectively.

4. A penalty of 0.5% per week of the contract value will be levied for delay in response time for attending and rectification of faults beyond specified time during the guarantee period as detailed above.

5. Maximum penalty to be levied on account of guaranteed failure shall be 10% of contract value calculated during whole of contract period and after that if there is any delay on the part of supplier, purchaser shall be entitled for encashment of bonds. In such cases of bad performance of firm during the guarantee/warranty period, the same shall be recorded and circulated to all railways. The same shall be given due regard in deciding future orders on the firm and when evidence to the contrary is not available, the firm may be even rejected.

Payment Terms: 100% payment will be allowed after successful supply, receipt and acceptance of the item at consignee's location against inspection certificate and submission of BG to the consignee, for an amount of 5% of contract value towards warranty obligations, which shall be valid for a period beyond 02 months after the expiry of warranty period. BG/FDR is released after warranty period completion. (The supplier should submit No claim certificate and details of B G/FDR to the consignee).

Other conditions:

1. Bidders are advised to bring any deviation(s) from the additional specifications provided. In case, these deviations are not indicated, it will be presumed that the offer of bidder is as per additional specification in all respect. Any ambiguity shall be to the disadvantage of the bidder.

2. Firm undertaking: I/We hereby undertake not to withdraw or modify or impair or derogate from the bid in any respect within the period of validity of this bid/tender. I/we undertake that the information/documents furnished in this bid are not false, misleading or forged. On later date any documents/Information furnished by me/us is found misleading or forged or false, we shall bear the responsibility for the same and we are liable to be prosecuted and penalized as per law of the land.

7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
