2. MATERIAL DETAILED CATALOG OF THE PRODUCTS SHOULD BE SUBMITTED ALONG WITH THE BID.
3. Arbitration Clause: All disputes, differences, questions and claims arising out of, under or touching upon this Tender /Agreement/ Purchase Order/ Work Order shall be settled amicably between the parties through mutual discussion and failing that, such disputes, difference, questions or claims shall be referred for resolution through arbitration to the India International Arbitration Cen

tre or a Sole Arbitrator to be appointed by the Chairman-cum-Managing Director of HOCL and the award of Arbitration shall be final and binding on the parties. 10. The Tenderer must specify their GSTIN No & HSN code of material offered in the BID.
11. The successful tenderer shall, if so desired by HOCL, deposit an amount equivalent to 5% of the value of order as security deposit within 21 days of the order towards satisfactory execution of the order. No interest will be paid on this amount by HOCL.
12. Delivery will be as per delivery schedule given by HOCL in the BOQ.
