1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
2. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
3. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
5. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 50% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU / Public Listed Company. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

4. Latest GST Clearance Certificate.

assessment report. OEM Certificate along with details such as name, designation, address, email id and phone no bid no required to be furnished along with the bid.

10. The Bidder/OEM should have ISO 9001:2015 (Quality Management System), ISO 14001:2015 (Environment Management System) ISO 45001:2018 (Occupational Health & Safety Management System) certification.
11. Test Report by NABL Lab.
12. The Bidder should have completed any same or similar work minimum amounting of 50% of Bid estimated value during last three financial years with any Govt/Semi Govt./ ULB in India, Work Order along with any supply proof to be attached.
13. The Bidders should have an Average Annual Turnover of value not less than 50% of Bid estimated value during last three financial years. A Turnover Certificate issued by Chartered account with mentioning UDIN to be attached.
14. The equipment offered shall be with a Minimum local content of 50% (Class-I) as per Government order No. P-45021/2/2017-PP dated 16.09.2020. The Bidders shall upload component wise documentary evidence for local content of minimum 50% (manufactured within India) under MAKE IN INDIA by self-certification/ undertaking that the equipment offered meets the required local content.
15. Documentary proof of bidder having established at least one (01) fully functional Owned Service Center within district, with details like Registration, Address etc. to ensure spare part availability of the offered equipment as per requirement of the department on S.O.S. basis and minimize equipment downtime.
16. Bidder financial standing:- The bidder should not be under liquidation court receivership or similar proceeding should not be bankrupt. Bidder to upload undertaking to this effect with bid.
17. Availability of spare-parts of the equipment's must be assured for minimum 5 years. Undertaking in this regard must be submitted by the bidder along with the bid.
18. Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regard GST reimbursement will be as per actual or as per applicable rates (whichever is lower). Subject to the maximum or quoted GST%.
19. Dedicated/Toll free telephone no for service support: Bidder/ OEM must have dedicated/Toll free telephone no for service support.
20. Scope of supply (Bid price to include all cost components): Supply installation testing commissioning of goods and training of operators and providing statutory clearances required (If any).
21. Successful bidder will have to ensure that adequate number of dedicated technical service personals/engineers are designated / deployed for attending to the service request in the time bound manner and for ensuring timely servicing / rectification of defects during warranty period, as per service level agreement indicated in the relevant clause of the bid.

23. Undertaking of Termination of Contract

Time shall be the essence of the contract the purchaser shall have the right to terminate this contract without any notice in part or in full in any of the following cases:

- a) The delivery of the material is delayed for causes not attributable to force majeure after the scheduled date of delivery.
- b) The seller is declared bankrupt or become insolvent
- c) The delivery material is delayed due to causes of force majeure by more than 60 days.
