1. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1 + 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY. The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023 [OM No.1_4_2021_PPD_dated_18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017.
4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of

quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

A) Guarantee/ Warrantee :- The firm shall be fully responsible for the manufacturer's comprehensive warranty with respect to proper design, quality, workmanship and proper functioning of the material for which these are intended, for a period of 36 months from the date of final acceptance of materials at ultimate destination. The Supplier shall be responsible for any defects that they develop under the conditions provided for by the contract and under proper use, arising from faulty materials, design or workmanship and shall remedy such defects at his own cost when called upon to do so. If it become necessary for the supplier to replace or renew any defects portion of the goods, such replacement or renewal should be made by the supplier without any extra to WCL. The warranty claim is to be cleared by the supplier within 3 days of the receipt of the same.

B) No Deviation Certificate:- The bidder should declare that there should not be any deviation from the terms and conditions in the offer submitted by them against the present Bid.

C) Delivery Schedule: Within 30 days from date of issue of Contract

D) Security Deposit :- 05% of Contract Value will be submitted online or through Bank Guarantee in SFMS mode and refunded after completion of Supplies & submission of e-PBG. (Applicable for contract having value more than 05 Lakhs). State / Central Government organizations / Public Sector Undertakings are exempted from submission of security Deposit.

E) INSPECTION: Final Inspection of the consignment shall be carried out at the destination stores, which will be arranged by the consignee on receipt of stores. WCL reserves the right to reject the goods which do not confirm to the specifications

F) Payment Terms :- 100% payment within 21 days after receipt and acceptance of Material by consignee and generation of CRAC & submission of security Deposit whichever is later

G) Banned Or Delisted Or Debarred Or Put On Holiday Suppliers Declaration :- The bidder have to certify that they have not been banned or de-listed or debarred or 'Put on Holiday' by any Government or quasi-Government agencies or PSUs

H) Documents in Support of Experience Criteria: Bidder or its OEM (themselves or through resellers) should have supplied tendered/similar item(s) of same /similar (TV of 75 Inch or above shall be considered similar item) /higher specifications/ratings/versions etc during the last 5 years from the date of tender opening against order of CIL and its subsidiary, other PSUs, Government Department and private organizations,

Copy of GST Invoice/CRAC/Delivery Challan etc document along with offer for submitted purchase order/contract) to be submitted along with bid in support of quantity supplied.

8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
