Bidders are bound to accept the orders accordingly.

Important Terms & Conditions

☐ Bidder/ Seller need to provide sample of all required items/ Spares with same specification as per OEM within one day for timely checking of fitment in respective Equipment/vehicles.

☐ Bidder/ Seller need to provide replacement of items without any charges in case spares/ Items not fitted in respective Equipment/ System.

☐ Bidder/ Seller need to provide local service centre for repair action, if items/ spares get damage during warranty period and Bidder / Seller will be fully responsible for return if damage or not repaired.

☐ Bidder /Seller are provide replacement of items/ Spares as the same as new, if any spares are damaged at the time of fitment or not repaired during warranty period.

☐ If any items damaged/ Not working smoothly/ Defective found/ Etc. under warranty period then seller / Bidder are required to deliver one day replacement required for smooth function of the same.

□ Otherwise seller/ bidder will be disqualified.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
