Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY. 1. Kindly confirm that you shall supply the material as per attached specification
2. Unit of measurement is Pair. Bidder should quote offer in pair only
3. Deviation, if any, quoted by bidder should be attach in separate sheet
4. You shall submit duly signed and stamped copy of acceptance of all additional terms and condition (ATC) and document uploaded in buyer uploaded ATC document on your letter head
5. Payment term shall as follows:
100 % payment shall be released within 30 days after receipt and acceptance of material at NFL Stores, Panipat. Vendor should provide their latest bank details (valid bank mandate/ cancelled cheque copy/on their letterhead, etc.) at the time of invoice submission
6. Supplier/ vendor whose turnover exceeds Rs.5.00 Crore in any financial year from 2017-18, is required to issue E-Invoice as per the provision of Rule 48 of CGST Act, 2017. If the supplier/ vendor fails to comply with the provision of Rule 48, such invoice will not be a valid invoice and the recipient/ buyer will not be entitled to claim the Input Tax Credit of GST paid as per section 16(2)(a).
