Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY. 1. Scope of Supply

2. Buyer Added Bid Specific ATC

1. Kindly confirm that, design particular, performance, MOC and approval of the item shall be as per attached specification.

2. Kindly confirm that you shall submit the approval documents as per section-e of the attached specification along with the offer.

3. Kindly confirm that you shall submit the size chart of your clothing along with offer.

4. Kindly confirm that you shall provide demonstration and training of the Hot Liquid Protective Suit at NFL Panipat site without any extra cost to NFL.

5. Kindly confirm that the size of the suit shall be of two configurations. The medium configuration size should offer proper fitting to wearer having height upto 5.5 ft and large configuration size should offer proper fitting to wearer having height upto 6ft. Item is required is sizes Medium configuration- 01 ST and Large configuration- 03 ST.

6. Kindly confirm that you shall submit Warranty certificate against any manufacturing defects and satisfactory field performance for a period of 12 months from the date of supply along with supply of material.

7. Payment term shall as follows:

100 % payment shall be released within 30 days after receipt and acceptance of material at NFL Stores, Panipat.

8. Successful Vendor on which contract is placed shall provide their latest bank details (valid bank mandate/ cancelled cheque copy on their letterhead, etc.) at the time of invoice submission

9. Supplier/ vendor whose turnover exceeds Rs. 5.00 Crore in any financial year from 2017-18, is required to issue E-Invoice as per the provision of Rule 48 of CGST Act, 2017. If the supplier/ vendor fails to comply with the provision of Rule 48, such invoice will not be a valid invoice and the recipient/ buyer will not be entitled to claim the Input Tax Credit of GST paid as per section 16(2)(a). 7. Floating / creation of work contracts as Custom Bids in Services.
