1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. 3. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- If number of technically qualified bidders are only 2 or 3.
- If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

### **Technical Pre-Qualification Criteria**

The bidder must satisfy the conditions as stipulated below to qualify in technical evaluation. The bidder must submit the documentary evidence in support of their eligibility, failing which the offer is liable to be rejected.

1. The party should have successfully executed minimum one order for supply of air filter for Compressors, valuing Rs.1 lakhs or multiple orders with a cumulative value of Rs.1 lakhs in any one of the three financial years preceding the date of submission of tender.
2. The executed orders shall be from any Govt.organization /Public Sector Undertaking /public limited companies/private limited companies.
3. The parties participating in the tender should be a manufacturer or their authorized dealer / distributor. Traders with valid authorization from manufacturer on the date of tender shall also be eligible to participate. The parties shall submit document

ary evidence in support of their eligibility (i.e. Purchase Order, Supply Invoice/Delivery Challan)

4. Party shall submit self-attested documents in support of the above .

Inspection Plan: Based on the vendor's conformance certificate confirming the item supplied is as per the NSL specification and visual inspection on receipt of the material at NSL site.

Guarantee / Warranty - The items shall be under Warranty for 18 months from the date of supply or 12 months from the date of commissioning, whichever is earlier, against manufacturing defects, faulty materials and bad workmanship.

**Payment terms:**

**Advance payment terms are not acceptable and is liable for rejection of the tender.**

Our standard payment terms: within 30 days of receipt of material against GRN.

**PENALTY:**

If the Seller fails to deliver any or all of the Goods within the original delivery period(s) specified in the contract, the Buyer will reserve the right to levy/deduct/recover the penalty for the delay @ 0.5% of the order value of the un-delivered quantity for each week or part thereof but subject to maximum **5%**(five percent) of the total basic order value.

Rejection and replacement: All replacements shall be done at site free of cost. In case of rejection, the supplier has to make all arrangements to lift the rejected item. NSL reserves the right to demand for submission of security deposit in the form of Bank Guarantee for the equivalent value of the material, if the same is taken out of NSL's custody for the purpose of replacement.
