1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
2. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
3. Bid reserved for Make In India products: : Procurement under this bid is reserved for purchase from Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. However, eligible micro and small enterprises will be allowed to participate. The minimum local content to

qualify as a class 1 local supplier is denoted in the bid document. All bidders must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which the bid is liable to be rejected. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020 . In case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedence over this clause.

4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

5. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

**1. Generic**

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

**2. Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

**3. Generic**

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

**4. Buyer Added Bid Specific ATC**

**1. Terms and Conditions in Buyer Uploaded Additional Terms and Conditions (ATC) documents supersedes the system generated terms & conditions.**

**2. Tolerance Clause.** To take care of any change in the requirement during the period starting from issue of ATC till placement of the **Acceptance of Tender Note/Supply Order**, Buyer reserves the right to **25 %** plus/minus increase or decrease the quantity of the required goods upto that limit without any change in the terms & conditions and prices quoted by the Seller. While awarding the contract, the quantity ordered can be increased or decreased by the Buyer within this tolerance limit. **(This tolerance clause supersedes system generated option clause of 25%).**

**3. EMD.**

(a) **Physical Deposition.** Instrument of Payment of EMD in Original shall be submitted physically in the sealed tender box or sent by registered speed post **(as per details given at Para 5 of Part-I of buyer uploaded bid specific ATC documents)** by all vendors except MSE firms.

(b) **e-BG.** The e-BG will be prepared in favour of **UIN-NCDGA2387P**. The e-BG so submitted will be verified on the NeSL portal, failure in authentication of the same will render the bid invalid) shall result in rejection of bid **(as per details given at Para 5 (b) of Part-I of buyer uploaded bid specific ATC documents)** by all vendors except MSE firms.

4. **Performance Guarantee.** The successful bidders will be required to furnish a Performance Guarantee by way of FDR/ BG in favour of '**PCDA, NEW DELHI**' or Bank Guarantee in favour of '**PRESIDENT OF INDIA**', payable at Delhi issued by any Indian Public or Pvt. Scheduled Commercial Bank in prescribed format or **e-BG (in favour of UIN-NCDGA2387P)** for a sum equal to **5% of the contract value within 10 working days** (as per instructions contained in the AT Note/ Supply Order) of issue of the confirmed order. If Performance Guarantee is not received within 10 working days of issue of the confirmed order, the EMD will be forfeited and contract will be cancelled unless reasons for delay in submission of Performance Guarantee is furnished by the bidder and the same are accepted by the Competent Authority based on the merit of the case. Instrument of Performance Guarantee should be valid up to 60 (Sixty) days beyond the date of warranty. The specimen of PBG is given in Form DPM-15 copy of which is attached as **Appendix 'L'**. **(Please refer Para 1.1 of Part IV(A) of buyer uploaded bid specific ATC documents).**

5. **Participation in Schedule.** The SELLER will have the option to quote for either all Schedule or one or more Schedule. But the SELLER will have to quote for the entire quantity for one single schedule for which tender has been invited and should not quote for partial quantities in one schedule. L1 will be decided separately for each schedule. Any tender wherein partial quantities are offered against the individual schedule will be declared invalid and ignored totally at the discretion of the Procurement Committee/ competent authority **(Please refer Para 3 of Part II, Para 2.3 of Part IV (B) and Appendix 'J' of buyer uploaded bid specific ATC documents).**

6. **Payment Terms and Conditions.** For payment terms and conditions, mode of payments and documents required to be submitted to paying authority i.e, PCDA, New Delhi. **Please refer Para 3, Para 4 and Para 5 of Part IV(A) Special Conditions of ATC of Buyer Uploaded Bid Specific ATC documents.**
