The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to

increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

3. **Scope of Supply**

Scope of supply (Bid price to include all cost components) : Supply Installation Testing Commissioning of Goods and Training of operators and providing Statutory Clearances required (if any)

4. **Warranty**

Warranty period of the supplied products shall be 3 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.

5. **Buyer Added Bid Specific ATC**

1. Attendance of pre-bid meeting by all participating firms is mandatory to understand the scope of work clearly by visiting the site at Porbandar.
2. Participating firm should have successfully completed installation of minimum 02 projectors of 7000 lumens and higher at premises of any central/state govt dept/ PSUs/ Multiplexes during last 05 years. Work Completion Certificate indicating the same must be uploaded by the bidder for technical evaluation.
3. bidder is required to indicate model of projector and lens clearly while submitting its bid.
4. The L1 firm is required to position its service engineer for attending to any problem during warranty period, within 72 hours of reporting of defect/problem by the buyer. Further, the firm is required to address the issue maximum within next 05 working days at buyer premises only. If the issue is not resolved within these 05 working days, then the firm has to provide an alternate projector system of same rating on its own expense at buyer site till the problem is resolved by the firm. Failing to do so, the PBG held with the buyer will be encashed by the buyer. A Self Certification document is required to be submitted to the buyer during technical evaluation.
5. Payment for the item will be processed by the buyer only on successful completion of installation and operation trials of projector at buyer site and on award of Work Completion Certificate by the buyer. No advance/ part payment will be processed till the work is completed by L1 firm.
