1. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the

bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Copies of relevant contracts (proving supply cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

9. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. 2. Sample Clause

After award of contract – Successful Bidder shall have to get advance sample approved from buyer before bulk manufacturing / starting bulk supplies. Successful Bidder shall submit

samples for Buyer's approval, within 5 days of award of contract. Buyer shall, as per contract specifications framework, either approve the advance sample or will provide complete list of modification required in the sample within 7 days of receipt of advance sample. Seller shall be required to ensure supply as per approved sample with modifications as communicated by Buyer. If there is delay from buyer side in approval of advance sample – the delivery period shall be refixed without LD for the period of delay in sample approval. In case, the sample is found to have major deviations / not conforming to the Contract specifications, the buyer at its discretion may call for fresh samples for approval before allowing bulk supplies or may terminate the contract after notifying the deviations to the seller.

2. **Vendor Compliance Matrix.** All bidders must submit the vendor compliance matrix duly filled and signed by an authorized signatory of the firm (Appendix t).

3. **Delivery of Advance Sample/Stores** The vendor will be responsible to deliver the sample/stores at buyer location i.e. 3 Inf Div Ordnance Unit, Leh. No representation will be accepted for change of Delivery Location.

4. **Vetting of Advance Sample and Bulk Delivery (Receipt Inspection)**

- (a) The receipt inspection will be carried by a Board of Officer constitute

by the buyer. The advance sample and bulk delivery will be evaluated against the parameters and depot sample. All perimeter as per specification and sample available with this depot will be individually checked during receipt inspection.
