Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 100%(selected by Buyer) percentage of total QUANTITY. 1. Only OEM i.e. M/s Lucas TVS or their authorized dealer can only participate in the bid . Party has to submit valid authorization certificate for the same along with the offer
2. Kindly confirm that you shall submit Warranty certificate against any manufacturing defects for a period of 12 months from the date of supply along with supply of material.
3. Kindly confirm that you shall submit interchangeability certificate along with supply of material.
4. Kindly confirm that supplied material shall be as per attached specification
5. Payment term shall as follows:
100 % payment shall be released within 30 days after receipt and acceptance of material at NFL Stores, Panipat. Vendor should provide their latest bank details (valid bank mandate/ cancelled cheque copy on their letterhead, etc.) at the time of invoice submission
6. Supplier/ vendor whose turnover exceeds Rs. 5.00 Crore in any financial year from 2017-18, is required to issue E-Invoice as per the provision of Rule 48 of CGST Act, 2017. If the supplier/ vendor fails to comply with the provision of Rule 48, such invoice will not be a valid invoice and the recipient/ buyer will not be entitled to claim the Input Tax Credit of GST paid as per section 16(2)(a).
