2. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. 3. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

4. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. 5. Procurement under this bid is reserved for purchase from Micro and Small Enterprises whose credentials are validated online through Udyog Aadhaar for that product category. If the bidder wants to avail the reservation benefit the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service.

6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The Technical Specification of the Multi Gas Detector shall be as follows: -

- a. Multi Gas Detector should be compact. Portable, lightweight, hand held for use in underground mine for detection of Methane (CH₄) , Carbon Monoxide (CO), Hydrogen Sulphide (H₂S) ,Oxygen (O₂) and Carbon Dioxide (CO₂) in general body of air .**(Q3)**
- b. The instrument should have valid DGMS approval (Main and thereof) on the date of opening of tender as well as on the date of supply of material to the consignee for using in degree I,II and III gassiness mines for continuous monitoring
- c. The DGMS approval No. should be marked/engraved/embossed on the body of Multi Gas Detector
- d. The supplier shall submit duly notarized and self-attested copy of main and revised DGMS approval certificate with the offer as well as at the time of supply of Multi Gas Detector.
- e. Measurement range (at least) of the instrument should be

Instrument shall be constructed of a high strength non-corrosive polymer material with an integral rubber boot to be durable against the accidental dropping from a height of 01m, instrument should be designed to be avoid accidental shut off.
- h. The unit shall be IP67 and above proven for ideal dust and water protection without losing its measuring performance capacity.
- i. The instrument should be able to work efficiently in atmospheric temperature up to 50⁰C and Relative humidity of 95% approximately.
- j. The instrument must have rechargeable NIMH battery with power backup. The rechargeable battery pack shall provide minimum 9 hour and more operating time under normal working condition. Charging time is less than 4 hours
- k. The instrument shall be provided with both audio and visual alarms.
- l. The instrument shall be digital, rechargeable and should have facility for connecting probe to allow measurement at inaccessible areas of mines.
- m. The supplier should submit purchase order copy for same quoted DGMS approved item for three year earlier or more to CIL and its subsidiaries /Government Dept/Private Organizations to ensure that the instrument is working satisfactory in U/G mines.
- n. Service life of the detector should be a minimum of 09 years.
- o. All other parameters of the instrument should be as per DGMS approval
