1. Generic

2. **Generic**

4. **Generic**

- 2) Make & Model and Product Catalogue/ Broucher: The party should mentioned the Make & Model of various furniture items in their quotation. Relevant Product Catalogue/Broucher is to be submitted along with their quotation mentioning Model No. and other technical details of quoted items.
- 3) Bidders should have relevant experience for similar nature of Job. In this regards, bidders needs to submit relevant documents as applicable like PO copy, Completion certificates etc. with their quotation.
- 4) Warranty: Warranty for all the items will be applicable upto at least 1 year from the date of final acceptance & installation.
- 5) Package Order: All the items will be procured from a single/same supplier as a package order for the sake of coherence & easy co-ordination during installation. As such the party has to quote for all items (Sl. No . 1 to 8), partial quote is not acceptable.
