1. 19. Breach of contract, Remedies and Termination:

In case of breach of contract, wherever the value of security instruments like performance bank guarantee

available with BHEL against the said contract is 10% of the contract value or more, such se

curity

instruments to the extent of 10% contract value will be encashed. In case the value of the security

instruments available is less than 10% of the contract value, the balance amount will be re covered in all or

any of the following manners:
