1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023.

2. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY.The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023

2. **Buyer Added Bid Specific ATC**

Bid conditions:

(1) Quotation to meet drawing requirements.

(2) Quantities indicated are tentative. There may be change in Quantities at the time of release of P.O. based on the requirement.

(3) Quoted rates shall be firm for a period of one year and any additional quantities shall be supplied at the same rate.

(4) Quoted rates shall be on F.O.R. / FDD BEML-KGF basis.

(5) Bushes are to be supplied with suitable packing.

(6) Payment Terms: Payment term for MSES is as per MSME act & 100% receipt and acceptance-60 days for all others.

(7) firms falling under MSME category should attach latest MSME certificate (registration on TREDs) along with the bid. firms are also requested to mention gst tin number and hsn code applicable for the part in their bids.

(8) Delivery Schedule: As per bid.

(9) (i) Sources who are registered with BEML and have already supplied Nonferrous items to BEML Limited only to participate.

(ii) Supplies to meet Drawing requirement to qualify for consideration of quotation.

(iii) Any new firm interested in supplying / developing the subject item may contact us through mail id gokulchandra.sr@bemltd.in Development action will be initiated based on BEML requirements after ascertaining the capability of the firm.

(10) If the Supplier exceeds any agreed delivery date(s) or period(s), Purchaser shall levy LD for such delay @0.5% per week (7 days) and part thereof, subject to a maximum of 5% of the value of the delayed portion of the Purchase Order. The penalty/ LD will be charged on the value of the Purchase Order excluding statutory levies freight and insurance wherever not included in the price. Imposition, recovery or Settlement of this LD shall not affect Purchaser's right to performance, compensation and termination of the agreement.

(11) Successful bidder shall accept to supply the material in staggered lots as per BEML requirements.

(12) BEML reserves the right for Deferment, Re-scheduling, Cancellation/short/P re-closure of the Tender and Purchase Orders as and when required.

(13) All other terms shall be as per BEML Standard Terms & General T&C.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in

9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
