Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

## 2. **Scope of Supply**

Scope of supply (Bid price to include all cost components) : Only supply of Goods

## 3. **Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

- 1) The bidder shall offer their rate including all taxes and charges. Inclusion of Additional charges after Submitting the offer and opening of price bid is not acceptable /not possible in GEM portal.
- 2) The bidder shall sign and seal in all the pages of tender document as a token of acceptance
- 3) Bidder shall submit their deviations if any against the tender conditions in deviation sheet attached.
- 4) Bidder shall submit their offer only as per the specification in the enquiry cum offer sheet.
- 5) Vendor shall submit the offer including the TPI charges wherever applicable.
- 6) Payment terms: Payment shall be within 30 days from the date of materials receipt and acceptance by CPCL.
- 7) Bid validity: The bid validity shall be the 120 days from the date of opening of the tender.
- 8) Delivery period: Delivery period is 4 weeks from the date of receipt of PO.
- 9) Price reduction clause of ½ % on the order value (Excluding taxes) per week delay to the maximum of 1 0% is applicable as per GEM tender terms.
- 10) Evaluation will be based on item wise evaluation.
- 11) Bidder shall provide the LC (local content) declaration in their letter head

## **Disclaimer/अस्वीकरण**

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
