1. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

### 2. Buyer Added Bid Specific ATC

Pre Bid [Meeting](#):- Pre Bid Meeting will be held on board ship IN LCU L53. All desirable bidders are required to attend this meeting for detail justification of items. Bidders who will failed to attend this meeting treat as disqualified.

## Disclaimer/अस्वीकरण
