5. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. 6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
7. ## **1:20 scale Model**

**Model total length 550mm x 125mm width x 255mm height**

**Model base size:- 630mm length x 200mm width x 60mm height**

**With transparent Enclosure Height 450mm**

1. Model will be made of international standard quality.
2. Surface finish will be high glossy well finished as per international standard.
3. Models will be made by FRP that will be made by high viscosity Gel coat , / Epoxy Resin, CSM 300, WRM 600.
4. Small parts will be made using PP, PVC and BRASS & SS materials
5. As FRP would use the strength of the model would be strong enough for rough handling.
6. Model base will be made by 18mm plywood with High Glossy Epoxy marble structure FRP laminated surface coat.
7. Imported Japan made 4mm Thickness Transparent Acrylic cover will be provided.
8. The colour scheme as per original or as per your suggestion.
9. PU Resin based colour will be used for painting purpose and for better durability.
10. PU Resin based laminate coat will be applied for better glossy purpose.
11. Model will be wrapped with suitable soft foam materials around the model for safety handling and transportation purpose.
12. The model packing box would be made by 12mm Heritage/Eco-Tech plywood with good quality sun mica will be laminated.
13. SS handle and Nylon ribbon would be fixed on boxes for easy carriage purpose.
14. Inside the packing box soft foam cushioning would be placed so as the model is not damaged during transportation.
15. Name plates made using by 1mm SS 304 would be fixed on the base of model
