Buyer's Responsibility: Buyer will ensure well ventilated/covered site/room having requisite power points/distribution board to provide input power to Inverter as well as to take out power from Inverter. The above is not applicable for the stores supplied without installation and commissioning.

If service center is not already there at the time of bidding, successful bidder/OEM shall have to submit signed declaration to establish one within 30 days of award of contract (**Bidder must submit signed declaration for the same at the time of bid**). Payment shall be released only after submission of document evidence of having Functional Service Center.

3. Dedicated / Toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated /toll free Telephone No for Service Support.
