1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the

"OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.

2. In case of bunch bids, the category of primary product having highest value should meet this criterion.

4. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. 5. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Generic

1.3 Contract Period: Contract Period for this job is 12 (Twelve) months from the date of site handover.

1.4 Scope Of Work: This job shall be executed outside Refinery Premises and in different locations of Assam. Following are the brief and general scope of works: i. **This job shall be executed outside Refinery Premises and in different locations of India.** ii. **Materials shall be delivered to NRL site, i.e. Numaligarh, for installation outside Refinery Premises.** iii. **For installations in different NRL locations across India, the material will be delivered directly at the respective locations as per advice from NRL E I/C** iv. Delivery shall be in staggered lot as per requirement. v. Post Inspection of Material will be done in NRL premises. vi. The materials need to be collected from NRL Warehouse in case of installation outside Refinery premises. vii. The installation and commissioning shall be completed without any additional cost.

1.5 Scope Of Supply: All materials, tools & tackles, etc. for execution of the job is under the scope of the contractor. The contractor shall take prior permission from the EIC before procurement of any consumables. All items to be procured as per specification mentioned in the tender. 2. Site Organogram: Subject to the provisions in the contract document and without prejudice to Contractor's liabilities and responsibilities to provide adequate qualified skilled, semi-skilled and unskilled personnel on the work, contractor shall deploy construction manpower as specified and directed by the Engineer-in-Charge and augment the same as decided by the Engineer-in-Charge depending upon the site requirement & the exigencies of work so as to complete all works within the contracted time schedule and without any additional cost to NRL.

Other Points:

1) Two Years warranty as per the bill date.

2) Six Months extended CMC service package should be included in the cost.

3) Authorized Service Center with Office Address in Assam, preferably in Jorhat Region.

4) Lumens should be as per the Specification given.

5) Post Inspection of Material will be done in NRL premises.

6) All Point need to be fulfilled else Vendor will be rejected by NRL. Note: Penalty for delayed supply from the date of issue of order. Order shall be placed in staggered lot as per requirement.
