Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY. The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017.

2. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Scope of Supply

Scope of supply (Bid price to include all cost components) : Only supply of Goods

Vendor Evaluation Criteria:

1. Offer from Original manufacturer /Authorized dealer of the above mentioned items will only be accepted .
2. Dealer shall upload the valid dealership authorization certificate from OEM along with the offer , without which the offer will be rejected.

Item Acceptance Criteria:

1. The inserts and tool holders shall be inspected (dimensional and visual inspection) at NFC and shall meet the dimension / geometry as per the standard nomenclature.
2. The supplier shall supply initially 5 nos. of inserts, 5 nos. of chip breakers as mentioned in the purchase order. The performance of the same will be checked on zirconium alloy slabs for oxide layer removal of 3 mm depth on four faces of slab i.e 2 faces of (360-420) mm x (220-228) mm & 2 faces of (360-420) mm x (110-118) mm for 10 shifts. Items will be accepted only after meeting all the technical requirements.

Bid Evaluation:

1. Offer will be evaluated based on the cumulative cost of all the items.
2. The supplier shall upload/submit technical details of the offered model along with their offer.

IMPORTANT NOTES FOR BIDDERS

1)Bidder shall furnish Land boarder certificate enclosed herewith without fail, without which your offer shall not be considered for evaluation.

5) DELIVERY INSTRUCTIONS:

a) Stores are to be delivered to the Store Keeper (Receipt and Inspection) at the place of delivery stipulated in the Contract between 10.30 a.m. and 3.00 p.m. on working days.

b) No stores shall be accepted by the Store keeper (Receipt and Inspection) unless delivery challan giving full details of the Contract Number and Date and Description of Stores, Quantity, Make, Unit, Gross Weight Tare Weight are submitted with the stores. In the absence of any of the above, the Store Keeper (Receipt and Inspection) shall refuse to take delivery of the stores. The supplier should submit the warranty/ guarantee card/certificate along with the Delivery Challan in whichever case it is applicable while effecting delivery of item.

c) A receipt for the packages only and not for the contents will be given by our Central Stores initially. The Suppliers are advised to properly seal the package. Final receipt will be given from the Central Stores, after inspection.

Driver's Note: The drivers, while bringing the material in motor vehicles into NFC premises, shall carry their respective original driving license to facilitate security checks properly before entering inside NFC premises without any delay.

In case the contractor is unable to deliver the goods within the delivery schedule stipulated in this Contract, it is mandatory on his part to approach the purchaser for extension of the delivery date with justification for the delay for consideration of the purchaser.

The contractor should deliver the goods only after getting the delivery period extended by the purchaser. In case the contractor fails to adhere to this condition and deliver the goods to the consign

ee after expiry of the delivery date without getting the delivery period extended, it is not only that the consignee will not receive the goods dispatched by the suppliers but the bills if any furnished by the contractor will be rejected without any liability and obligation on the part of the Purchaser.

This will not in any way prejudice the other rights of the purchaser under the terms and conditions of the Contract.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
