1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum

local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. 2. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY.The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023

3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

4. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Scope of Supply

Scope of supply (Bid price to include all cost components) : Only supply of Goods

Vendor Qualification Criteria:

(a) Offer from original honing stick manufacturer or their authorized dealers/distributors will only be accepted. Authorization certificate shall be submitted along with their offer.

(b) Participating bidder shall have previous experience in supply of CBN honing sticks. P.O. copy for previous supply shall be submitted along with the offer.

8. Delivery schedule: The entire quantity shall be delivered within 4 months from the date of Purchase order. The firm shall supply initially 50 nos. of honing sticks. These sticks will be used for honing of Zircaloy tubes as mentioned above and remaining quantity shall be supplied only after acceptance of 50 nos. of sticks.

IMPORTANT NOTES FOR BIDDERS

1. Offers mentioning any terms which are contradictory to our NIT shall be summarily rejected.

2. MAKE IN INDIA (MII Declaration):

As per MII policy, bidders shall confirm/furnish percentage of the local content involved. If not provided the bidder shall be considered as Non- Local Supplier; and their offer shall be summarily rejected.

7) NOTE:

On placement of contract, seller has to upload soft copy of PSDBG at GeM portal and shall submit original hard copy of the same to the buyer, however within 15 days from the date of release of contract, failing which incident as per GeM terms and conditions shall be raised.

8) DELIVERY INSTRUCTIONS:

a) Stores are to be delivered to the Store Keeper (Receipt and Inspection) at the place of delivery stipulated in the Contract between 10.30 a.m. and 3.00 p.m. on working days.

b) No stores shall be accepted by the Store keeper (Receipt and Inspection) unless delivery challan giving full details of the Contract Number and Date and Description of Stores, Quantity, Make, Unit, Gross Weight Tare Weight are submitted with the stores. In the absence of any of the above, the Store Keeper (Receipt and Inspection) shall refuse to take delivery of the stores. The supplier should submit the warranty/ guarantee card/certificate along with the Delivery Challan in whichever case it is applicable while effecting delivery of item.

c) A receipt for the packages only and not for the contents will be given by our Central Stores initially. The Suppliers are advised to properly seal the package. Final receipt will be given from the Central Stores, after inspection.

Driver's Note: The drivers, while bringing the material in motor vehicles into NFC premises, shall carry their respective original driving license to facilitate security checks properly before entering inside NFC premises without any delay.

In case the contractor is unable to deliver the goods within the delivery schedule stipulated in this Contract, it is mandatory on his part to approach the purchaser for extension of the delivery date with justification for the delay for consideration of the purchaser.

The contractor should deliver the goods only after getting the delivery period extended by the purchaser. In case the contractor fails to adhere to this condition and deliver the goods to the consignee after expiry of the delivery date without getting the delivery period extended, it is not only that the consignee will not receive the goods dispatched by the suppliers but the bills if any furnished by the contractor will be rejected without any liability and obligation on the part of the Purchaser.

9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
